Purpose of the proposal and its anticipated effects, including any changes in existing rules: The department proposed pilot rules under WSR 25-20-083 to implement Section 16 of Engrossed Substitute Senate Bill 5291 (Chapter 380, Laws of 2025) for a pilot project from January 1, 2026, through June 30, 2026. The proposed rule missed addressing services provided by a financial management services vendor under WAC 388-116-4030. The draft rules adds language to clarify that beneficiary reimbursement and other services by a financial management vendor are not permitted during the pilot.

Reasons supporting proposal: This rulemaking is necessary for the WA Cares Fund program to set parameters for pilot participation.



WAC 388-116-1030 Additional service limitations for pilot. (1) Reimbursing eligible beneficiaries, acquisition of adaptive equipment and technology on behalf of a beneficiary, and processing claims for provider payments by a financial management services vendor are not permitted during the pilot.

(2) This section is effective through June 30, 2026.
