

# AREA AGENCY ON AGING CONTACTS FOR INTERESTED PROVIDERS



The WA Cares Fund requires providers to have a contract with at least one Area Agency on Aging or the Department of Social and Health Services before providing services. You must reach out to each Area Agency on Aging you would like to contract with individually.

## AAA services include:

- Adult day services, including adult day care and adult day health
- Dementia and behavioral support
- Education and consultation
- Home modifications
- Home-delivered meals
- Home safety evaluations
- In-home personal care and respite with home care agencies
- Personal emergency response system
- Professional nursing services, specifically skilled nursing
- Housework and errands
- Yardwork and snow removal
- Transportation

If you offer any service statewide, DSHS will process your application and manage your contract regardless of the service type.
