#### SERVICE DESCRIPTION – EDUCATION AND CONSULTATION

Teach the beneficiary, and paid and unpaid caregivers the skills to accomplish specific goals, such as (but not limited to):

- The use of adaptive equipment or medical-related procedures
- Medication management
- Maintenance or adjustment to serious disease or impairment, including reduction of fall risk and stress management
- Self-management of chronic disease
- Acquisition of skills to address minor depression
- Management of personal care needs, including the development of skills necessary to work with caregivers

<sup>i</sup> Monthly recurring (RB) means the units/dollars are for each month in the date span. Span multiple (MB) means if the authorization is for multiple months, the units/dollars are spread over the entire span of months and can be billed multiple times within the span. Span single (SB) means If the authorization is for multiple months, the units/dollars are for the entire span of months and can only be billed one time (on a single date of service).

\*EBPs with SB - Span Single are to be pre-authorized and billed as "per course" or "per program," the length of which will vary by program. EnhanceFitness is monthly recurring and is available to pre-authorize and claim once per month for the length of the pre-authorization.
