GENERAL DESCRIPTION OF SERVICE

There are two available subcodes included in the Education and Consultation contract. One is for medical providers, and the other is for non-medical providers.

The service provides beneficiaries, and caregivers (including paid and unpaid family members) non-medical education, consultation, and training regarding the beneficiary's diagnoses and chronic health issues aimed at supporting the beneficiary to better manage their activities of daily living and their health and wellness.

The service also includes evidence-based programs that support health and wellness, including but not limited to:

- A Matter of Balance
- Chronic Disease Self- Management Education programs (CSDMP)/ Tomando Control de su Salud (Spanish CDSMP)
- Community Aging in Place-Advancing Better Living for Elders (CAPABLE)

MINIMUM PROVIDER QUALIFICATIONS

1. Contractors must meet all Washington state laws to do business in the state (and city or county requirements, if applicable). This includes having all required business license(s), endorsement(s), credential(s) and certification(s) to provide the service.
2. The agency owner/contract signatory must pass a DSHS criminal history background check at initial application and contract renewal.
3. All employees, volunteers, and subcontractors who may have unsupervised access to beneficiaries must have passed a criminal history background check, which must be conducted by the contractor prior to access and every two years. The criminal history background check must at least include Washington State Patrol criminal conviction records and be kept in their personnel or subcontractor file(s).
4. Meet DSHS insurance requirements.
5. The Contractor must meet the following qualifications for the education and training provided. Further, the Contractor and its employees must maintain all necessary license, registration, and certification as required by law. Applicable licensing laws include but are not limited to the following:
 - a. Registered nurse license under [Chapter 18.79 RCW](#) and [Chapter 246-840 WAC](#)
 - b. Licensed practical nurse under [Chapter 18.79 RCW](#) and [Chapter 246-840 WAC](#)
 - c. Certified dietician/nutritionist certification under [Chapter 18.138 RCW](#)
 - d. Physical therapist license under [Chapter 18.74 RCW](#)
 - e. Occupational therapist license under [Chapter 18.59 RCW](#)
 - f. In-home services agency license under [Chapter 70.127 RCW](#) and [WAC 246-335](#), for home health services or home care agency
 - g. Community college as higher education institution conducting programs under [Chapter 28B.50 RCW](#)
 - h. Community behavioral health agency license under [Chapter 71.24 RCW](#)
 - i. Pharmacist license under [Chapter 18.64 RCW](#)
 - j. Trainers or facilitators of evidence-based programs must meet the fidelity and qualification requirements with the credentialing organization where they are certified, credentialed or licensed.

- l. Board-certified music therapist with active credential
- m. Recreation Therapist under [Chapter 18.230 RCW](#) and [Chapter 246-927 WAC](#)
- n. Contracted health home care coordination organizations associated with a health home lead entity that employs individuals with the applicable license, credential, or certification
- o. Learning Management System approved by DSHS, including but limited to [CareLearn Washington](#).

PROVIDER CONTRACT

Education and consultation contracts have a maximum duration of four years. The sample contract linked below is for informational purposes. This information is available to review to ensure all contract terms can be met before application. Providers must meet the qualifications for each subcode they include in their contract. Both subcodes are included in the sample contract.

1. Completed Provider Intake Form and Required Attachments
2. Evidence that specific provider qualifications are met
3. Proof of current liability insurance certificate(s)
4. Current rate(s), for informational purposes only
5. Copy of your policies and procedures regarding mandatory reporting procedures, as described in [Chapter 74.34 RCW](#), related to the protection of vulnerable adults
